



## Gender-Sensitive Judging for ICC Judges and Judges of other International Courts and Tribunals

On 13 November 2021, Africa Legal Aid (AFLA) held the fifth meeting in its Gender-sensitive judging series. The topic of discussion was 'Gender-sensitive judging in international criminal law' and was presented by Dr Rosemary Grey of Sydney Law School, the University of Sydney.

The discussion was held in three parts: Why gender-sensitive judging is important for international criminal tribunals; Some concrete examples and some concrete missed opportunities for gender-sensitive judging in the ICC and other international courts; and Common myths and misperceptions about sexual violence which judges should be aware of and should try not to reproduce in their judgements.

The presentation was followed by lively and engaging discussions with additional suggestions from the participating judges.
